A Commitment to Excellence and Personal Choice

Choices in Quality Services Change Lives. In May 2014, the Herkimer ARC received The Council on Quality and Leadership's (CQL) Accreditation—which deems the organization as an agency of excellence in person-centered services and as a leader in providing choice to individuals with disabilities.

The accreditation process includes organizational commitment, preparation, selfassessment, on-site visits by CQL review teams, and an ongoing partnership agreement. For more than 40 years, CQL has been a leader in working with human service organizations and systems to continuously define, measure, and improve the quality of life of all people.

Herkimer ARC President/CEO Kevin Crosley commented, "With New York State's directive to begin the transition to move to a managed care system, this designation will be important for families looking for agencies that have demonstrated excellence in providing person-centered services of the highest quality. To date, a small percentage of the agencies that provide services for people with disabilities in New York have received this accreditation. CQL Accreditation is an invaluable label to have in our portfolio. The Herkimer ARC ultimately earned this accreditation due to the high level of commitment from staff, board members, families, and the individuals supported," he said.

The Herkimer ARC community worked through a rigorous process to review services and supports to prepare for CQL Accreditation, which provided an excellent opportunity for the organization to take an in-depth look at itself. The agency will continue to work with CQL to ensure people with disabilities have more informed choices in selecting services best suited to meet their needs.

Creating a Park for People of All Abilities

Recreation Choices Change Lives. The HARC Community Park, with a price tag of \$1 million, will be located behind the HARC Business Park in Herkimer, NY. The project, in collaboration with the Village of Herkimer, will include: athletic fields, fitness trails and stations for people of all abilities, multi-generational play areas, a basketball court, a softball field, covered and lighted bocce courts, a picnic pavilion, a bandstand, rest rooms, and a concession stand.

The 2014 fund raising strategy for the HARC Community Park Capital Campaign included friends of the Herkimer ARC hosting small intimate events at their homes—giving opportunities for Herkimer ARC President/CEO Kevin Crosley and VP - Fund Development Dominic Frank to meet friends of the hosts and to explain the merits of the Park. Three events were held in 2014 and their encouraging results bode well for the successful completion of the Campaign.

Another component of the Campaign's strategy is connecting the Park to sources of grant funds. As a regional asset the Park is attractive to foundations seeking projects that promote regional resources and meet specific objectives. Of note, the Jim and Juli Boeheim Foundation awarded the Campaign \$10,000 to refurbish the existing basketball court located on the grounds of the future Park. Over \$550,000 of the \$1 million goal has been pledged and committed to the Park. Crosley perceives 2015 as a year that will significantly raise sufficient funds allowing for the beginning of the construction of the Park in Spring 2016.

Breaking Records to Support Employment and Services

Jobs Change Lives. For the third year in a row, Herkimer Industries (HI) set a new sales record topping \$4.465 million dollars—a 10.6% increase over 2013. Preferred Source Contract Sales through NYSID also set a record exceeding \$2.153 million. New York State agencies, which include the State Police, the Department of Homeland Security and Emergency Services, and the New York State Thruway, were the largest state contract customers in 2014. HI received its largest single purchase order in its history with 10,000 Officer Down Kits assembled for the purchase by the Department of Homeland Security for the officers of the New York City Police department.

Highlights from 2014 contract packaging include a new contract with Walmart. Workers assembled and shipped more than 8,000 Black Friday displays that were sent to over 600 stores from Maine to Virginia. Otis Technology also set a record in sales after placing several of their products in large-box stores. HI was a strategic partner in helping to meet demand.

Herkimer ARC VP - Industrial Operations Michael Lamb said, "In demonstrating that Herkimer Industries delivers quality services and products, our business partners—from federal and state agencies to one of the largest gun manufacturers—provide us with additional opportunities to increase our sales. These projects not only put people with disabilities and others to work in integrated work settings, they also provide business revenue to support underfunded and unfunded programs."

Nurse Practitioner Leads Reorganized Clinical Team



Quality Clinical Services Change Lives. In March 2014, Debra Ray, ANP, joined the Herkimer ARC as VP - Clinical Services, and under her leadership, she's brought together clinical departments that include nursing, occupational therapy, speech, and counseling services.

Ray's department's goals: to work smarter not harder and to be more proactive than reactive. "I've got a great, caring team," she said. "We all work together to ensure we are providing vital and quality services to help prevent chronic health issues. Not only are regulations constantly changing in the health care arena, but the people we support are aging and that can create many different needs. We are striving to provide care that is continual across the many programs at the agency. For example, if someone has a medical issue during their day at program, we want to ensure that care is continued at home and vice versa. We've had very positive feedback working with the various programs." To further assist collaboration, the clinical departments meet together once a month for lunch and then a clinical meeting.

NYSARC Trust Grant Provides Choices in Recreation

Recreation Programs Change Lives. Thanks to a \$10,000 grant from the NYSARC Trust Services Board, children, teens, and adults enjoyed life enriching activities while participating in Herkimer ARC's recreation programs. The 2014 grant provided new or expanded recreation programs for people with intellectual or other developmental disabilities. The Herkimer ARC utilized the grant throughout the year to offer Tai Chi and pottery classes, a writing/illustration clinic for adults, and summer camps for children: Camp Nazareth and Utica Zoo camp.

În total, \$2,207,880 in NYSARC Trust Services remainder grants were awarded in 2014 to support recreation and guardianship statewide.

"NYSARC Trust Services' generous grant increased by \$4,000 over last year, which helped to create fun and exciting activities," said Herkimer ARC VP - Day and Community Supports Susan Streeter. "Two of our newest offerings that were covered by the grant included a six-month Tai Chi program and a six-week writing/illustration clinic. Tai Chi truly enriched the lives of those who took the course. The program helped to improve concentration, balance, and muscle tone. The writing/illustration clinic was also very popular and the participants published their books. Due to a decrease in government funding for programs, the NYSARC Trust Services grant is even more vital in assisting the agency to offer both fun and worthwhile recreation programs," she said.

Direct Support Professional Wins National Award

Dedicated Staff Change Lives. Abby Hnydowitz, a Herkimer ARC day habilitation lead, received the 2014 NADD Direct Support Professional Award for Excellence given at the 31st Annual Conference held in San Antonio, TX in November. NADD is a national association for persons with developmental disabilities and mental health needs. Their mission is to advance mental wellness through the promotion of excellence in mental health care.

This prestigious annual award acknowledges a DSP, whose contributions to supporting people who live in the community have resulted in significant improvement in the quality of life.

Hnydowitz earned the accolade for her dedication, advocacy, compassion, person-centered approaches, and collaboration that resulted in improved quality of life, health and wellness, and opportunities for individuals.

Since 2011, Hnydowitz has worked with the Herkimer ARC's Gentlemen's Group, comprised of six men, who participate in the Bridges to Success Day & Community Supports program. The gentlemen participate in many activities, including lawn maintenance, travel, and gardening, among others. Hnydowitz has been nurturing the men to become artists and they are now selling their artwork at a retail center and at the agency's New York International Wine Auction. They have also won awards for their art pieces. They turn recycled materials into artistic treasures and in the process are creating their own beautiful stories of friendship, acceptance, and independence.

Investing in Community - Supports Services

Community Leaders Change Lives. In 2014, the Burrstone Road Associates, LLC donated the Ilion Mall in Ilion, NY to the Herkimer ARC. Plans are similar to those executed at the Business Park: renovations and upgrades to the facilities to support local manufacturing projects and leasing commercial space. The Herkimer ARC pays taxes to area communities on all business enterprises that do not directly employ or provide services or housing for individuals with disabilities in accordance with federal/state tax exemption laws. For example, the space utilized by commercial tenants, who are not providing services, is taxable within local municipalities' tax bases. Ultimately, the agency's business ventures generate revenue to offset government cuts to maintain programs or to create new services for people with disabilities.

The Herkimer ARC continues to create and maintain partnerships with for-profit and nonprofit companies to diversify funding streams, to create business and job options, and to provide vital and meaningful programs for people with disabilities. With a \$24 million budget and a \$11.4 million payroll, the agency remains an important area employment leader with employees investing dollars back into the community.

The HARC Business Park continues to grow—creating and maintaining jobs and attracting 15 tenants to renovated commercial space.



Personal Choice Defines Home

Choices in Home Change Lives. Robert Rowland and Gerry Lopata have two different thoughts about living within a house community and what home feels like. After living in nursing homes for the past 17 years as a double amputee, Rowland and his family craved a change: a positive, home-like atmosphere that did not feel like an institution. He no longer wanted to be cared for by people on shifts—living in a room with a bed and a chair. He wanted staff to support him and to respect his space and to help him regain independence. Before nursing homes, he lived much of his childhood and adult life with his mother, until she passed away.

Lopata, who currently lives with five other gentlemen, wanted a living space of his own—beyond his own bedroom. He retired from work and day habilitation programs and he was set to enjoy some peace and quiet. Herkimer ARC began planning how to help Rowland and Lopata achieve their person-centered goals and dreams. Herkimer ARC residences are considered individuals' homes and staff is there each day to support them in daily living activities and goals.

According to VP - Residential Services Shawn Schultz, living amongst many people is not always easy. "We know in our own daily lives that there are always differences, disagreements, discussions, and compromises in our homes," Schultz said. "This is no different for the individuals we support in Residential Services. Our goal is to provide opportunities and resources to help people live as individualized lives as possible within their current homes with their house mates. We work specifically with the people we support to assist them in having the same living opportunities any of us would have within our own homes."

Finding Home With a New Family. Rowland says he loves his home and the staff. He particularly enjoys going to community events and working on crafts. After living unhappily in nursing homes, he is very happy with his new life at a Herkimer ARC residence. "Since I came here a year ago, I've come a long way," said Rowland. "The people who support me here have taught me how to take responsibility for my feelings and my health. I've lost 35 pounds and I am careful what I eat because of diabetes."

Residence Manager Jessica Lamanna said, "Family is very important to Robert. His sister and his niece see him often, but we've become his family too. He helps cook and he does his own laundry. These are things he could not do at a nursing home."

Rowland also voiced a desire to learn how to read. Staff has been helping him to decipher words and he is also mastering books with the help of technology. He is now content sharing his time playing Wii Bowling and shopping with roommates, going to dances and Bingo, and enjoying social activities. Dinner is shared with his new family each night and he loves sitting on his porch.

Creating Solitude. According to Lopata's Residence Manager Richard Carnright, "After retiring, Gerry voiced that he wanted his own living space that would have a feel of an apartment. Staff set out to change a large storage room, down the hall from his bedroom, into a living room complete with a couch and recliner, refrigerator, and a large 55" flat screen television. Now that he has his own area, we are able to assess Gerry's happiness and his skills for living independently. We've not only honored his request for his own space, we've given him more time alone. We work to ensure he knows what to do in an emergency. He enjoys walking by himself to downtown to pick up a snack during the day."

Lopata is really enjoying his new living area and the solitude. "I wanted my own space. I love my new TV. It has more action and power. I get to watch the shows I want to watch when I want to watch. I really like TV Land and Nick at Nite. I also like when the house is quiet and I can be alone," he said.

HMS Host Honored for Supporting Employees

Employers Change Lives. Career Connections, the employment division of the Herkimer ARC, honored HMSHost and its employee, Michael Wood, with a New York State Office for People with a Developmental Disabilities (OPWDD) "Works for Me" award. The recognition honors selected businesses across New York State that demonstrate employing individuals with developmental disabilities is great for business. The award also recognizes that employees are valued members of the state's vibrant workforce.

Herkimer ARC President/CEO Kevin Crosley said, "HMSHost and Mike serve as a wonderful example of what a great working employer-employee relationship should be. Mike has a full-time job at the New York State Thruway Iroquois Travel Plaza in Little Falls, he has been employed there for 21 years, and his work is truly valued. Career Connections staff members work every day to find jobs for individuals with disabilities—all who are very willing and capable of working in the community. Sometimes barriers make this search and placement challenging. HMSHost is one of those exemplary companies that have supported our mission to allow individuals to reach their full potential and to live enriched lives."

Vice President of Day and Community Supports Susan Streeter explained that HMSHost Assistant District Manager Bruce Nadeau and his team go beyond just employing Wood—they have become like family. "Mike lost his girlfriend, Nancy, of over 30 years to cancer. He was given time off to spend the final days with her. His boss and peers attended her services and Bruce keeps a picture of Mike and Nancy on his desk. Such concern and support goes beyond a typical 9 to 5 work setting. In return for being a dedicated and hardworking employee for HMSHost, Mike is supported and is recognized for what he brings to the custodial division," Streeter said.

Seeking What Matters Most to People in Their Lives

Empowering People Changes Lives. Jessica French, a Quality Assurance specialist at the Herkimer ARC, completed the Trainer Certification Process administered by The Council on Quality and Leadership (CQL). French will assist the agency in continuing to develop a culture of person-centeredness by teaching Personal Outcome Measures (POM) interview workshops and related trainings.

The Herkimer ARC was accredited by CQL in May 2014 for its continuing work to promote excellence in person-centered services and supports that lead to increased quality of life for individuals. Services are based upon what matters most to the individuals served.

As a certified trainer, French taught her first four-day course in November 2014 to a group comprised of Herkimer ARC and other area ARCs staff members. French also worked with Amanda Jeffreys, who is supported by the agency, to help her to become a Personal Outcome Measures interviewer. Jeffreys is now a part-time employee of the Herkimer ARC. She will assist in conducting POM interviews with persons supported to gather information to assess what supports are present or not present in people's lives in order to assist individuals and their support teams in individualized planning.

Connecting with Friendships

Friendships Formed to Change Lives. They are bound together by goals and similar interests. For the past year, a new group of five young women has been meeting on Mondays to learn to build and maintain positive relationships with others while gaining meaningful work experiences. They are learning through giving time to projects such as planting flowers in the community and cleaning a local community park. The group also enjoys visiting the Mohawk Homestead, an adult care residence for the elderly. The women chat and play games with the seniors,—learning to get to know others in their community while having fun.

According to Valerie Eaker, a Herkimer ARC direct support professional, "They are a positive group and they all get along very well together. We are always looking for community sites where we can interact with people and help out our community."

The Women's group is one of various other volunteer/social groups at the Herkimer ARC. The groups' goals are to integrate with community members and to understand and teach the value of being involved and giving back to help others. Each week throughout the year, volunteer groups go to community organizations, such as the National Center for Missing & Exploited Children, to help with mailings. They also fold church bulletins and help clean firehouses, among other activities.

These groups also learn to give back to a generous community. In 2014, several groups hosted a food drive and collected hundreds of pounds of food and canned goods for the local food pantries. Another group delivered school and art supplies for children, who participate in a Head Start program, and canvas bags full of personal care items to seniors.

Passion for Work Changes Lives. Career Connections, the employment division of the Herkimer ARC, assists people with disabilities and others in the community, who are seeking employment to obtain meaningful work based on each person's needs, desires, and abilities.

Career Connection staff assisted 83 individuals to secure community employment in 2014. After a job placement survey, 100 percent of the employers who hired these individuals were satisfied with Career Connection's assistance and 100 percent of the individuals employed were happy with their jobs. Tom Bergen is one of those individuals. He graduated from Mohawk Valley Community College in May 2014 with a degree in Graphic Arts Technology and a certificate in Small Business Management.

Bergen, who is diagnosed with autism, wanted to work in a profession he is passionate about: sign making. Bergen was then connected to All Events Engraving, a local business that specializes in engraving and graphic design, which is located in Bergen's home town. His job entails working on specialized engraving equipment, creating designs for plaques and gifts in computer graphics software, and designing, fabricating, and assembling plaques, trophies, and awards.

Manager Mike Malinowski said, "We love Tom. He is a wizard on the computer. He is willing to work at all times and he's interested in all aspects of the business. He is also great with our customers."

Bergen commented, "I absolutely love my job. I enjoy engraving and working with the technology. I am working at what I love." His ultimate dream: to someday own a sign company. He thinks he's gotten a great start.
